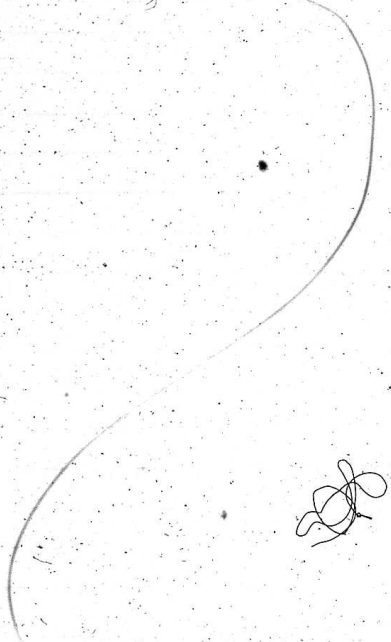

Victoria, by the Grace of God, of the United Kingdom of Great Britain and Ireland,

QUEEN, Defender of the Faith, &c. To all to whom these Presents shall come. Greeting:

KNOW YE. That We, of Our special grace, certain knowledge, and mere motion, have given and granted, and We do, by these Presents, for Us, Our Heirs and Successors, give and grant unto

Beloni Daigle his heirs and assigns a tract of land situate in the Parish of Acadieville in the County of Kent in our Province of New Brunswick and bounded as follows to wit: Beginning at a hemlock tree standing at the most southerly angle of lot number sixty granted to Marc Vontour in Acadieville Settlement, thence North twenty three degrees and thirty minutes East, fifty chains, thence South sixty nine degrees and thirty minutes East, twenty chains thence South twenty degrees and thirty minutes West, fifty chains to a fir tree and thence North sixty nine degrees and thirty minutes West, twenty chains to the place of beginning. Containing one hundred acres more or less and distinguished as lot number fifty eight Acadieville



and also particularly described and marked on the Plot or Plan of Survey hereunto annexed; together with all profits, commodities, hereditaments, and appurtenances whatsoever thereunto belonging, or in any wise appertaining; except and reserved, nevertheless, out of this present Grant, to Us, Our Heirs and Successors, all Coals, and also all Gold and Silver, and other Mines and Minerals: TO HAVE AND TO HOLD the said *Tract* of Land, and all and singular the Premises hereby granted, with their appurtenances, (except before excepted), unto the said *Beloni Daigle his heirs and assigns* FOR EVER.

PROVIDED always, and this present Grant is upon condition, that the same Grant be registered in the Secretary's Office of Our said Province of New Brunswick, to which Registry shall be attached a duplicate of the Plan hereunto annexed.
