KNOW YE, That We, of our Our special-grace, certain knowledge, and mere motion, have given
and granted, and We do, by these Presents, for Us, Our Heirs and Successors, give and grant unto

Vital Henry *lie* Heirs and Assigns,
a Tract of Land situate in the Parish of *Acaduville*
in the County of *Kent* in Our Province
of New Brunswick, and bounded as follows, to-wit:-

Beginning at a
birch tree standing on the south western side of
a reserved road at the north western angle of lot
number fifty one in Acaduville located to S
Dantour thence running by the magnet south
twenty degrees and thirty minutes west fifty chains
thence north sixty nine degrees and thirty minutes
west twenty chains thence north twenty degrees
and thirty minutes east fifty chains to a birch tree
standing on the south western side of a above
mentioned road and thence along the same
south sixty nine degrees and thirty minutes
east twenty chains to the place of beginning
Containing One Hundred acres more or less
and distinguished as lot number fifty
three in Acaduville Settlement

and also particularly described or marked on the Plot or Plan of Survey hereunto annexed; together with all profits,
commodities, hereditaments and appurtenances whatsoever thereunto belonging, or in any wise appertaining; except
and reserved, nevertheless, out of this present Grant, to Us, Our Heirs and Successors, all Coals, and also all Gold
and Silver, and other Mines and Minerals: TO HAVE AND TO HOLD the said *tract* of Land,
and all and singular the Premises hereby granted, with their appurtenances, (except before excepted), unto the said
Vital Henry lie Heirs and Assigns, FOR EVER.
