KNOW YE, That We, of Our special grace, certain knowledge, and mere motion, have given and granted, and We do, by these Presents, for Us, Our Heirs and Successors, give and grant unto

E. Pollett Burk his

Heirs and Assigns,

a Tract of Land situate in the Parish of *Rogerville*
in the County of *Northumberland*

in Our Province

of New Brunswick, and bounded as follows, to-wit:

Beginning at a maple tree standing on the western side of the reserved road at the north east angle of lot number sixty eight granted to John Puzan in the Pleasant Ridge Settlement, thence running by the magnet north forty five degrees west fifty five chains and sixty links thence north eighteen degrees east twenty chains thence south forty five degrees east fifty five chains and sixty links to a birch tree standing on the western side of the aforesaid reserved road, and thence along the same south eighteen degrees west twenty chains to the place of beginning containing One hundred acres more or less, and distinguished as lot number sixty seven in the Pleasant Ridge Settlement

and also particularly described or marked on the Plot or Plan of Survey hereunto annexed; together with all profits, commodities, hereditaments and appurtenances whatsoever thereunto belonging, or in any wise appertaining; except and reserved, nevertheless, out of this present Grant, to Us, Our Heirs and Successors, all Coals, and also all Gold and Silver, and other Mines and Minerals: TO HAVE AND TO HOLD the said *tract* of Land,

and all and singular the Premises hereby granted, with their appurtenances, (except before excepted) unto the said

Heirs and Assigns, FOR EVER.
