**Victoria**, by the Grace of GOD, of the United Kingdom of Great Britain and Ireland,  
QUEEN, Defender of the Faith, &c To all to whom these Presents shall come, *Greeting*:

KNOW YE, That We, of Our special grace, certain knowledge, and mere motion, have given and granted, and We do, by these Presents, for Us, Our Heirs and Successors, give and grant unto

*Placide Maillat* his Heirs and Assigns,  
a Tract of Land situate in the Parish of *Acadville*  
in the County of *Kent* in Our Province

of New Brunswick, and bounded as follows, to-wit:—

*Beginning at a maple tree standing on the eastern side of a reserved road at the south west angle of lot number fifty five granted to Joseph Maillat in the south east Rogerville Settlement thence running by the magnet south sixty nine degrees east sixty seven chains thence south twenty one degrees west fifteen chains thence north sixty nine degrees west sixty seven chains to a birch tree standing in the eastern side of the above said reserved road and thence along the same north twenty one degrees east fifteen chains to the place of beginning containing one hundred acres more or less and distinguished as lot number fifty four in the south east Rogerville Settlement*

and also particularly described or marked on the Plot or Plan of Survey hereunto annexed; together with all profits, commodities, hereditaments and appurtenances whatsoever thereunto belonging, or in any wise appertaining; except and reserved, nevertheless, out of this present Grant, to Us, Our Heirs and Successors, all Coals, and also all Gold and Silver, and other Mines and Minerals: TO HAVE AND TO HOLD the said *tract* of Land, and all and singular the Premises hereby granted, with their appurtenances, (except before excepted) unto the said *Placide Maillat* his Heirs and Assigns, FOR EVER. PROVIDED ALWAYS, and this present Grant is upon condition, that the same Grant be registered in the Secretary's Office of Our said Province of New Brunswick, to which Registry shall be attached a Duplicate of the Plan hereunto annexed.
