a Tract of Land situate in the Parish of

Northumberland*

in Our Province

of New Brunswick and bounded as follows to-wit:—

Beginning at a birch tree standing on the northern side of a reserved road at the south east angle of lot number One Hundred and Eleven granted to Isidore Legere in the northeast Rogerville Settlement, thence running by the magnet north seventy Chains, thence north sixty five degrees east fifteen Chains and fifty links, thence south seventy Chains to a beech tree standing on the northern side of aforesaid reserved road and thence along the same south sixty five degrees west fifteen Chains and fifty links to the place of beginning containing One Hundred Acres more or less and distinguished as lot number One Hundred and twelve in the northeast Rogerville Settlement

and also particularly described or marked on the Plot or Plan of Survey hereunto annexed; together with all profits, commodities, hereditaments and appurtenances whatsoever thereunto belonging, or in any wise appertaining; except and reserved, nevertheless, out of this present Grant, to Us, Our Heirs and Successors, all Coals, and also all Gold and Silver, and other Mines and Minerals: TO HAVE AND TO HOLD the said *tract* of Land, and all and singular the Premises hereby granted, with their appurtenances, (except before excepted), unto the said

Heirs and Assigns, FOR EVER.
