**Victoria**, by the Grace of GOD, of the United Kingdom of Great Britain and Ireland,  
QUEEN, Defender of the Faith, &c. To all to whom these Presents shall come, Greeting :

KNOW YE, That We, of Our special grace, certain knowledge, and mere motion, have given and granted, and We do, by these Presents, for Us, Our Heirs and Successors, give and grant unto

*Peterson Daigle his* Heirs and Assigns,  
a Tract of Land situate in the Parish of *Acadville*  
in the County of *Kent* in Our Province

of New Brunswick and bounded as follows to-wit:—

*Beginning at a beech tree standing on the southern side of the Acadville Road at the north west angle of lot number eighty nine granted to Pacificus Daigle in the Acadville Settlement thence running by the magnet south three degrees and thirty minutes west fifty one chains to the northern bank or shore of Rochebaugue River thence along the same following the Severn course thereof up stream in a westerly direction with a rectangular distance of sixteen chains thence north three degrees and thirty minutes east fifty six chains to a pine tree standing on the southern side of the Acadville Road aforesaid and thence along the same south eighty six degrees and thirty minutes east sixteen chains to the place of beginning. Containing unity five acres more or less and distinguished as lot number unity in the Acadville Settlement*

and also particularly described or marked on the Plot or Plan of Survey hereunto annexed; together with all profits, commodities, hereditaments and appurtenances whatsoever thereunto belonging, or in any wise appertaining; except and reserved, nevertheless, out of this present Grant, to Us, Our Heirs and Successors, all Coals, and also all Gold and Silver, and other Mines and Minerals: TO HAVE AND TO HOLD the said *tract* of Land, and all and singular the Premises hereby granted, with their appurtenances, (except before excepted), unto the said

*Peterson Daigle his* Heirs and Assigns, FOR EVER.

PROVIDED ALWAYS, and this present Grant is upon condition, that the same Grant be registered in the Secretary's Office of Our said Province of New Brunswick, to which Registry shall be attached a Duplicate of the Plan hereunto annexed.

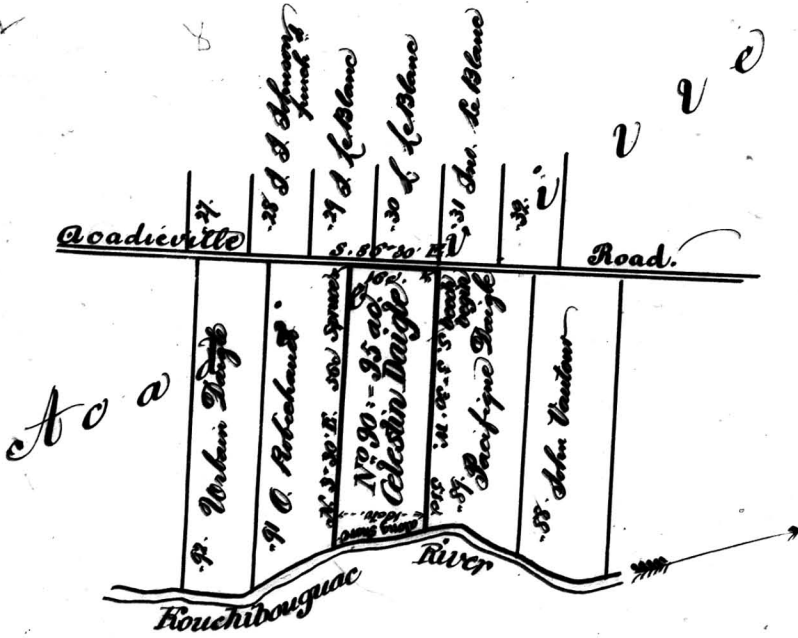
