KNOW YE, That We, of Our special grace, certain knowledge, and mere motion, have given and granted, and We do, by these Presents, for Us, Our Heirs and Successors, give and grant unto

Urban G. Gallien his Heirs and Assigns,
a Tract of Land situate in the Parish of *Rogerwill*
in the County of *Northumberland* in Our Province

of New Brunswick and bounded as follows to-wit:—

Beginning at a spruce tree standing on the south eastern side of the settlement road at the most western angle of lot number eighty four in the Collet Settlement thence running by the magnetic south twenty degrees east seventy seven Chains thence south seventy degrees west fifteen Chains thence north twenty degrees west seventy seven Chains to a fir tree standing on the south eastern side of the settlement road and thence along the same north twenty degrees east fifteen Chains to the place of beginning containing One Hundred acres more or less and distinguished as lot number Eighty three in the Collet Settlement

and also particularly described or marked on the Plot or Plan of Survey hereunto annexed; together with all profits, commodities, hereditaments and appurtenances whatsoever thereunto belonging, or in any wise appertaining; except and reserved, nevertheless, out of this present Grant, to Us, Our Heirs and Successors, all Coals, and also all Gold and Silver, and other Mines and Minerals: TO HAVE AND TO HOLD the said *tract* of Land, and all and singular the Premises hereby granted, with their appurtenances, (except before excepted), unto the said

Urban G. Gallien his Heirs and Assigns, FOR EVER.

PROVIDED ALWAYS, and this present Grant is upon condition, that the same Grant be registered in the Secretary's Office of Our said Province of New Brunswick, to which Registry shall be attached a Duplicate of the Plan hereunto annexed.

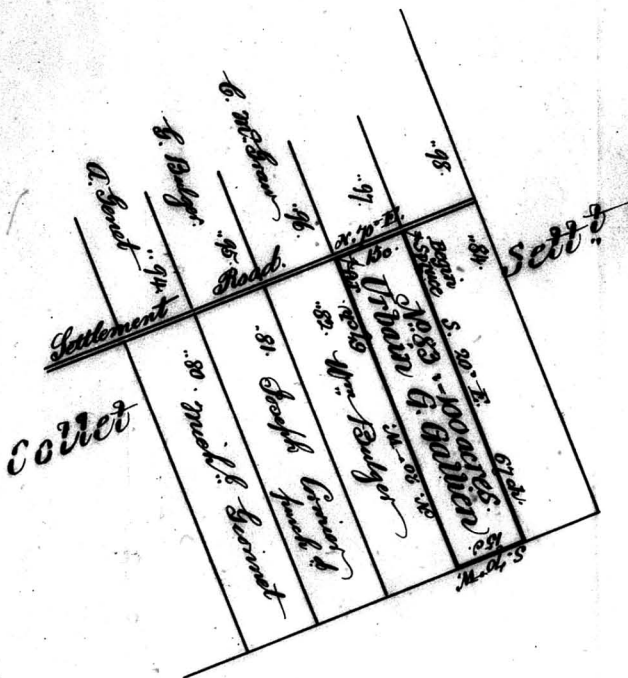
