in the County of *Northumberland* in our Province

of New Brunswick, and bounded as follows, to-wit:—

Beginning at a stake standing on the northern side of a reserved road at the southeast angle of lot number thirty eight in the Barnaby River Settlement west of Antecoloured Railway thence running by the magnet north one degree west fifty Chains thence north eighty nine degrees east twenty Chains thence south one degree east fifty Chains to a maple tree standing on the northern side of the aforesaid reserved road and thence along the same south eighty nine degrees west twenty Chains to the place of beginning. Containing One Hundred Acres more or less and distinguished as lot number thirty seven in the Barnaby River Settlement.
