**VICTORIA**, by the Grace of GOD, of the United Kingdom of Great Britain and Ireland,

Queen, Defender of the Faith, &c. To all to whom these Presents shall come, GREETING:

KNOW YE, That We, of our special grace, certain knowledge, and mere motion, have given and granted, and We do by these Presents for Us, our Heirs and Successors, give and grant unto

*Celina Poirier* his Heirs and Assigns,

Tract of Land situate in the Parish of *Acadewille*

in the County of *Kent* in our Province

of New Brunswick, and bounded as follows, to-wit:—

Beginning at a hemlock tree standing on the western side of a reserved road at the north east angle of lot number twenty two granted to Theophilus Martin in block ten Range Eleven Acadewille Settlement thence running by the Magnet north sixty nine degrees and thirty minutes west fifty Chains thence north twenty degrees and thirty minutes east twenty Chains to a maple tree standing in the southern side of another reserved road thence along the same south sixty nine degrees and thirty minutes east fifty Chains to a stake standing on the western side of the first aforesaid reserved road, and thence along the same south twenty degrees and thirty minutes west twenty Chains to the place of beginning containing one hundred acres more or less and distinguished as lot number twenty in block ten in Range eleven Acadewille Settlement

and also particularly described or marked on the Plot or Plan of Survey hereunto annexed; together with all profits, commodities, hereditaments and appurtenances whatsoever thereunto belonging or in any wise appertaining; except and reserved, nevertheless, out of this present Grant, to Us, our Heirs and Successors, all Coals, and also all Gold and Silver, and other Mines and Minerals: TO HAVE AND TO HOLD the said tract of Land and all and singular the Premises hereby granted, with their appurtenances, (except before excepted) unto the said

*Celina Poirier* his Heirs and Assigns, FOR EVER.
