KNOW YE, That We, of our special grace, certain knowledge, and mere motion, have given and granted, and We do by these Presents for Us, our Heirs and Successors, give and grant unto

Tract of Land situate in the Parish of *Roseville and Mustissou*

in the County of *Northumberland and Kent* in our Province

of New Brunswick, and bounded as follows, to-wit:—

*Beginning at a fir tree standing on the southern side of the Settlement Road at the northwest angle of lot number One Hundred and two purchased by Julie Bourke in the Pleasant Ridge Settlement West thence running by the magnet South Seventeen degrees east sixty seven Chains thence South Seventy three degrees west fifteen Chains thence north Seventeen degrees west sixty seven Chains to a stake standing on the southern side of the aforesaid Settlement Road thence along the same north Seventy three degrees east fifteen Chains to the place of beginning. Containing One Hundred acres more or less and distinguished as lot number One Hundred and four in the Pleasant Ridge Settlement West*

and also particularly described or marked on the Plot or Plan of Survey hereunto annexed; together with all profits, commodities, hereditaments and appurtenances whatsoever thereunto belonging or in any wise appertaining; except and reserved, nevertheless, out of this present Grant, to Us, our Heirs and Successors, all Coals, and also all Gold and Silver, and other Mines and Minerals: TO HAVE AND TO HOLD the said *tract* of Land
