KNOW YE, That We, of our special grace, certain knowledge, and mere motion, have given and granted, and We do, by these Presents for Us, our Heirs and Successors, give and grant unto

*Louis Barriault* - his - Heirs and Assigns,  
a Tract of Land situate in the Parish of *Acadieville*  
in the County of *Kent*. in our Province

of New Brunswick, and bounded as follows, to wit:— Beginning at a stake

standing on the eastern side of a reserved road, at the south west angle of Lot number six, in the Richard Settlement, as surveyed by Deputy Fish in eighteen hundred and ninety, thence running by the magnet South sixty nine degrees and thirty minutes East sixty seven chains thence south twenty degrees and thirty minutes West fifteen chains, thence North sixty nine degrees and thirty minutes West sixty seven chains to another stake, standing on the eastern side of the aforesaid reserved road and thence ~~along the same~~ North twenty degrees and thirty minutes East fifteen chains to the place of beginning - - - - - Containing one hundred acres, more or less, and distinguished as Lot number four, in the Richard Settlement.
