KNOW YE, That We, of our special grace, certain knowledge, and mere motion, have given and granted, and We do, by these Presents for Us, our Heirs and Successors, give and grant unto

Robert Caussy his Heirs and Assigns,

Tract of Land situate in the Parish of *Rogersville* in the County of *Northumberland* in our Province

of New Brunswick, and bounded as follows, to wit:— *Beginning at a stake*

standing on the eastern side of a curved road at the south west angle of Lot number sixty one purchased by Urbain W. G. Plante, in the south east Rogersville Settlement thence running by the magnet south sixty nine degrees east sixty seven chains thence south twenty one degrees west fifteen chains thence north sixty nine degrees west sixty seven chains to a spruce tree standing on the eastern side of the aforesaid curved road and thence along the same north twenty one degrees east fifteen chains to the place of beginning, Containing one hundred Acres more or less and distinguished as of number fifty, in the south east Rogersville Settlement

and also particularly described or marked on the Plot or Plan of Survey hereunto annexed; together with all profits, commodities, hereditaments and appurtenances whatsoever thereunto belonging or in any wise appertaining; except and reserved, nevertheless, out of this present Grant, to Us, our Heirs and Successors, all Coals, and also all Gold and Silver, and other Mines and Minerals; TO HAVE AND TO HOLD the said *tract* of Land and all and singular the Premises hereby granted, with their appurtenances, (except before excepted), unto the said

Robert Caussy his Heirs and Assigns, FOR EVER.

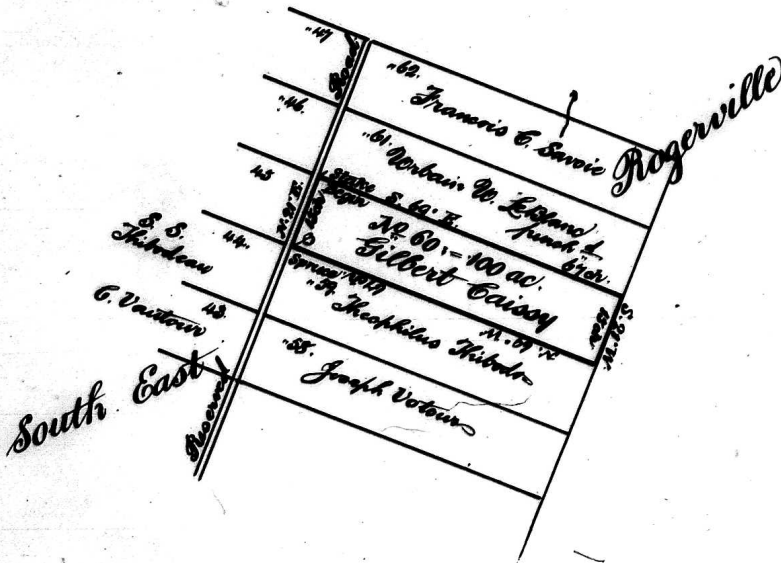
