KNOW YE, That We, of our special grace, certain knowledge, and mere motion, have given and granted, and We do, by these Presents for Us, our Heirs and Successors, give and grant unto

Denis L. Parreault his Heirs and Assigns,

a **Tract** of Land situate in the Parish of *Acadieville*

in the County of *West*.

in our Province

of New Brunswick, and bounded as follows, to wit:— *Beginning at a Stake*

standing on the Eastern side of the Settlement Road, at the South West angle of Lot number Ten, in the Richard Settlement, thence running by the magnet South sixty-nine degrees and thirty minutes East sixty-seven chains, thence South twenty degrees and thirty minutes West fifteen chains, thence North sixty-nine degrees and thirty minutes West sixty seven chains to another Stake standing on the Eastern side of the aforesaid Settlement Road, and thence along the same North twenty degrees and thirty minutes East fifteen chains to the place of beginning.

Containing One hundred acres, more or less, and distinguished as Lot number Eight, in the Richard Settlement.

and also particularly described or marked on the Plot or Plan of Survey hereunto annexed; together with all profits, commodities, hereditaments and appurtenances whatsoever thereunto belonging or in any wise appertaining; except and reserved, nevertheless, out of this present Grant, to Us, our Heirs and Successors, all Coals, and also all Gold and Silver, and other Mines and Minerals: TO HAVE AND TO HOLD the said *tract* of Land

and all and singular the Premises hereby granted, with their appurtenances, (except before excepted), unto the said *Denis L. Parreault*, his Heirs and Assigns, FOR EVER.
