KNOW YE, That We, of our special grace, certain knowledge, and mere motion, have given and granted, and We do, by these Presents for Us, our Heirs and Successors, give and grant unto

*Sebastian Voutour his* Heirs and Assigns,

a Tract of Land situate in the Parish of *Acadewelle*

in the County of *Kent*

in our Province

of New Brunswick, and bounded as follows, to wit:—

*Beginning at a Stake standing on the Western side of the Settlement Road, at the north east angle of Lot number One hundred and twenty one granted to Fabien M. Merzereau North Branch of M<sup>r</sup>. Louis Brook, thence running by the magnet north sixty nine degrees and thirty minutes West, eighty Chains to another Stake thence north twenty degrees and thirty minutes East twelve Chains and fifty links to another Stake, thence South sixty nine degrees and thirty minutes East, eighty Chains to another Stake standing on the Western side of the Western side of the aforesaid Settlement Road, and thence along the same South twenty degrees and thirty minutes West twelve Chains and fifty links to the place of beginning, Containing One hundred Acres more or less, and distinguished as Lot number One Hundred and Twenty two. 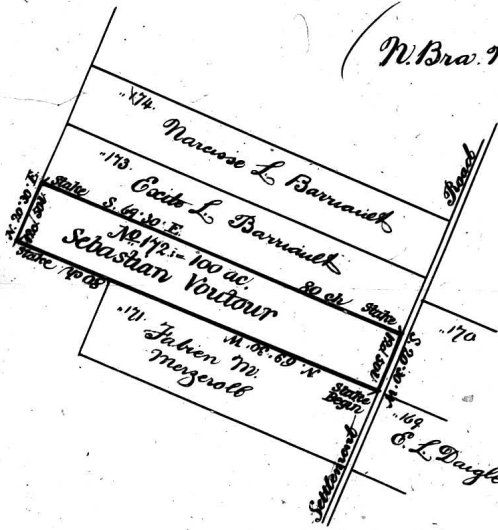
