Narcisse L Barriault his Heirs and Assigns,
a Tract of Land situate in the Parish of Acaderville

in the County of Kent

in our Province

of New Brunswick, and bounded as follows, to wit— Beginning at a stake

standing on the eastern side of the Settlement road at the southwes tangle of lot number twelve in the Richard Settlement there running by the magnet south sixty nine degrees and thirty minutes east sixty seven chains three south twenty degrees and thirty minutes west fifteen chains thence north sixty nine degrees and thirty minutes west sixty seven chains to another stake standing on the eastern side of the Settlement road aforesaid and thence along the same north twenty degrees and thirty minutes east fifteen chains to the place of beginning. Containing One hundred acres more or less and distinguished as lot number ten in the Richard Settlement

and also particularly described or marked on the Plot or Plan of Survey hereunto annexed; together with all profits, commodities, hereditaments and appurtenances whatsoever thereunto belonging or in any wise appertaining; except and reserved, nevertheless, out of this present Grant, to Us, our Heirs and Successors, all Coals, and also all Gold and Silver, and other Mines and Minerals; TO HAVE AND TO HOLD the said tract of Land,
