Victoria, by the Grace of GOD, of the United Kingdom of Great Britain and Ireland, Defender of the Faith, etc. To all to whom, these Presents shall come, GREETING:

KNOW YE, That We, of our special grace, certain knowledge, and mere motion, have given and granted, and We do, by these Presents for Us, our Heirs and Successors, give and grant unto

Maxime Potour, his Heirs and Assigns,

a Tract of Land situate in the Parish of Acadiville in the County of Kent in our Province

of New Brunswick, and bounded as follows, to wit:

Beginning at a Post standing at the North-western angle of Lot Number One Hundred and Sixty-one, surveyed for Frank Sillivau in Acadiville Settlement thence running by the Magnet of the year 1808 South twenty-one degrees and fifteen minutes West sixty-eight chains to another Post, thence North sixty-eight degrees and forty-five minutes West fifteen chains to another Post standing on the Western side of a Reserved Road, thence North twenty-one degrees and fifteen minutes East sixty-eight chains to another Post, and thence South sixty-eight degrees and forty-five minutes East fifteen chains to the place of beginning.

Excepting all that Part of the Settlement and Reserved roads running through the above described Tract.

Containing One Hundred Acres, more or less, and distinguished as Lot Number One Hundred and Sixty Acadiville Settlement,

and also particularly described or marked on the Plot or Plan of Survey hereunto annexed; together with all profits, commodities, hereditaments and appurtenances whatsoever thereunto belonging or in any wise appertaining; except and reserved, nevertheless, out of this present Grant, to Us, our Heirs and Successors, all Coals, and also all Gold and Silver, and other Mines and Minerals; TO HAVE AND TO HOLD the said Tract of Land and all and singular the Premises hereby granted, with their appurtenances (except before excepted), unto the said

Maxime Potour his Heirs and Assigns, FOR EVER.

PROVIDED ALWAYS, and this present Grant is upon condition, that the same Grant be Registered in the Secretary's Office of our said Province of New Brunswick, to which Registry shall be attached a duplicate of the Plan hereunto annexed.

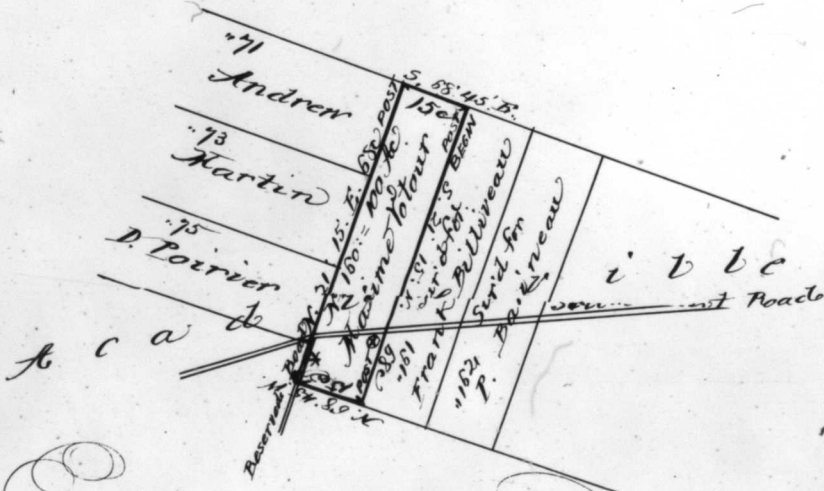
